

Policy Statement

St. John's College is committed to promoting sustainability and environmental responsibility in all aspects of its operations. This Energy, Green, Waste, and Environment Audit Policy outlines our commitment to regularly assess and improve our practices in these areas, aiming for reduced environmental impact and increased energy efficiency.

Objective

- c. Waste Management: Examine waste generation, disposal methods, and recycling programs. Develop strategies to minimize waste and increase recycling rates.
- d. Environmental Practices: Assess overall environmental practices, including landscaping, water usage, and conservation efforts. Recommend improvements to reduce the college's environmental impact.





Reporting and Documentation

Audit Reports:

The Audit Committee shall prepare comprehensive reports detailing findings, recommendations, and proposed action plans. These reports will be submitted to the College Administration for review.

Action Plans:

The College Administration will develop action plans based on audit recommendations, outlining specific steps, timelines, and responsible parties for implementation.
